



SCHEDULE OF FEES FOR EDUCATIONAL/FORENSIC/OCCUPATIONAL ASSESSORS (Effective 1st January 2017)

Fees for the Verification of new Assessors and the Verification of existing Assessors wishing to extend their Assessor's Certificate for a further 5 year period are listed below. An existing Assessor can apply for Reconfirmation or Re-Verification* at the same level(s) as their current Verification(s), however, if you wish to be verified at a different level, or in a different personality instrument, you will need to apply for a new Verification.

Occupational

Fee

- **Assistant Test User** (Module Set 4A)
Standalone Verification at this level is possible for those wishing to become verified in Assistant Test User only. **£100**
- **Test User Ability** (Module Sets 5A, 5B, 5D and 5E)
This level requires prior/concurrent verification of Module Set 4A (Assistant Test User) **£379**
- **Test User Personality** (Module Sets 5A, 5C, 5D, 5E).
This level requires prior/concurrent verification of Module Set 4A (Assistant Test User) **£379**
- **Specialist in Test Use** (Module Sets 7A and 7B)
This level requires prior/concurrent verification of Module Sets 4A, 5A, 5B, 5C, 5D and two instances of 5E, i.e. in two different personality measures.
This fee covers verification in Module Sets 7A and 7B only **£379**

Educational

- **Assistant Test User** (Module Set 4B)
Standalone Verification at this level is possible for those wishing to become verified in Assistant Test User only **£100**
- **Test User Ability/Attainment** (Module Sets 5F, 5G and 5H)
This level requires prior/concurrent verification of Module Set 4B (Assistant Test User) **£379**

Forensic

- **Assistant Test User** (Module Set 4C)
Standalone Verification at this level is possible for those wishing to become verified in Assistant Test User only **£100**
- **Test User (Forensic)** (Module Sets 5I, 5J, 5K and 5L)
This level requires prior/concurrent verification of Module Set 4C (Assistant Test User) **£379**

An administration fee of £73 is retained if an Assessor withdraws from the Verification/ Re-verification/Reconfirmation process before a Verification/Re-Verification/Reconfirmation visit (providing no charges have been incurred by Verifiers). The balance of the Assessor's fee is refunded to the Assessor.
